GENERAL CONDITIONS OF ENTRY

- Entry Forms:** Official forms are attached in each section of class details, Entries must be submitted using the official form provided. Any other forms of entry will not be entertained.
- Forms Submission:** Please complete the following forms for submission.
- .1 **Entry and Fees Form**
 - .2 **General Release for Liability and Waiver and Acknowledgement of Rules and Regulations Form**
- The Competition Booklet and its relevant forms will also be made available online at www.stc-ridingcentre.com**
- Entry/ Stabling Fees:** Please refer to the competition schedule. Entry fees and stabling fees must be paid in full together with the entry forms by the closing date. **Failure to submit all relevant fees with the forms may results in the disallowance of competitors from the competition.**
- Late Entry Fees:** Late entries for **Showjumping** will be allowable up to 30 minutes before start of Class. All permissible late entries will result in an **additional 50% of the stated entry fees. All forms would still have to be completely filled out and submitted.**
- Payment:** Payment must be made to the Centre latest by **10 April 2014, Thursday, 12.00pm**. Payment modes by Cash, Nets, Visa, Mastercard and cheques are accepted at our STCRC Reception Counter. Cheques are to be made payable to **Singapore Turf Club**.
- Veterinary/ Medical Withdrawals:** Entries cancelled after the closing date on **06 April 2014, Sunday, 12.00pm due to veterinary reasons** (eg, Lameness) must be verified with a veterinary medical certificate for a **50% refund** of the relevant fees provided that the cancellation is done before the competition date itself.
- Any Other Withdrawal:** Entries cancelled after the closing date on **06 April 2014, Sunday, 12.00pm due to any other reasons other than veterinary reasons** will not be eligible for any refunds.

GENERAL CONDITIONS OF ENTRY (continued)

**Horse Arrival and
Departure:**

Horses will be allowed into the stables on **13 April 2014, Sunday, 8.00am onwards**, and will have to leave the premise by the same date **after the completion of the last event.**

Horse Passport:

A duplicate copy of the horse passports must be submitted together with the entry forms. The original passport must also be made available for inspection upon entry into STCRC premise.

Vaccination Certificates:

A duplicate copy of the vaccination certificates must be submitted together with the entry forms.

Vaccination Types:

It is **MANDATORY** for competing horses to be vaccinated and immunized against the following:

- .1 Equine Influenza (EI)
- .2 Japanese B Encephalitis (Jap B)

Medical Records:

The medical records must indicate proper clearance. Once found any conditions are not compiled with, the horse will be denied entry into the premise and competition.

Insurance:

All owners and competitors are personally responsible for damages to third persons caused by themselves, their employees, agents and horses. They are therefore strongly advised to take out third party insurance providing full coverage for participation in Equestrian events and to keep their policies up to date.

The Organizer's Rights:

The organizer reserves the rights to:

- .1 Alter advertise competition timings
- .2 Cancel any classes or events due to insufficient and/or less than ideal number of competitors per class
- .3 Refuse any entries
- .4 Divide any classes
- .5 Change competition details including prizes
- .6 Increase and/or decrease the height of the fences depending on the entries
- .7 Charge any participating Clubs the cost of damages if found at fault

RULES AND REGULATIONS

Competition Rules:

If not wearing a jacket, solid color (Showjumping) short/long sleeved shirts with tie or choker are permitted. Leather gaiters of the same color as jodhpur boots are permitted instead of tall boots in all jumping classes.

Official club tee shirts may be worn in jumping classes below 90cm. Body protectors are permitted in all classes, but care must be taken with respect to potential heat exhaustion.

Jumping Classes 2 to 7 will run under FEI rules for jumping events under Table A (FEI jumping rules Art 238.1.2). For Classes 1 and 2 under 90cm, Table A will be modified as follows:

Second disobedience	Four penalties
Third disobedience	Elimination

Order will be drawn for first round (Not against the clock). In the event of equality of faults, riders will go in the same order for the jump off.

For other classes, rules may be posted the Show prior to the start of the respective class.

All instructions from stewards and officials are to be followed without dispute or delay; otherwise the competitor is liable to disqualification.

Course Design & Walk:

Course design will be made available on STCRC Notice Board prior to the start of the first class. Course walk will take place immediately after the completion of the course building for each class. Riders will be notified via the Public Address (PA) system.

RULES AND REGULATIONS (continued)

Prize Ceremony: Prize ceremony to be taken place immediately after each class during the course building for the next class. Competitors not attending the prize giving without notifying the organizers in advance will forfeit placing and prizes. Riders will have to don their jackets for the prize ceremony.

Prizes and Placings: One placing/prize awarded for 5 or fewer competitors;
Up to four placings/prizes awarded for 6 to 19 competitors;
Up to six placings/prizes awarded for 20 or more competitors.

Appeals: Appeals against any judging decisions, placing or events impacting the results or any class must be lodged with the Show Director in writing within 30 minutes of the official announcement of the result. All appeals must be accompanied by a deposit of S\$50.00 which will be returned in the event the appeal is upheld.

The appeal committee will review all appeals and announce its decisions as soon as possible pending the time taken to gather and review evidence. The decision of the appeals committee is final.

STABLES AND FACILITIES

- Grooms/ Syces:** Each club and/or competitor will have to supply for its own grooms or syces for this competition. They must be made aware of the general rules and regulations of the competition.
- Horse-Walks:** Horses walking to their warm-up and/or competing grounds must use the designated routes only. There will be adequate signage and directions provided. Horses will not be allowed to walk or exercise on any other non-designated areas.
- Vehicles at Stables:** Vehicles may park at the stables module/area. Care must be taken to park their vehicles in a safe and orderly fashion. Loading and unloading of horses should be done outside the stables module, at the road access near the guardhouse. **Entry to area in a vehicle must be via the side road access next to the guard house and not the main road entrance and exit.**
- Stables and fees:** **There are 25 temporary and 5 permanent stables available. Stabling per day of competition is S\$50.00 for temporary stables and S\$70.00 for permanent stables. Choice of the type of stables must be indicated in the entry form.**
- Horse Floats:** Return trips (To STCRC and from STCRC) are provided for, free of charge by Singapore Turf Club. Visiting Clubs/Centres must submit all relevant horse passports, entry and declaration forms before **10 April 2014, Thursday, 12.00pm**. Incomplete submissions and/or missing information in any of the forms will not guarantee float services for the horses.
- Washing of Horses:** Washing down of horses should be done at the designated areas only.
- Disposal of Waste:** Disposal bins will be adequately provided. At the end of the competition, all stables must be cleaned of all waste and left over feed.

STABLES AND FACILITIES (continued)

Cleanliness of Stables: STC reserves the rights to charge a penalty fee of S\$50.00 per stable to participating clubs should the stables be found to be in an unclean/ unsatisfactory state.

Water Buckets and Fans: Water buckets will be adequately provided.

Failure to comply with any of the above will result in competitors and/or clubs being charged for the repairs to the stables area and/or its surrounding areas.
